- A visit to the laboratory for a better understanding of the requirements is also encouraged.

#### 2. Application Cum Tender (Quotation) Form:

#### 4. Security Deposit:

- The successful tenderer must pay a minimum of Rs. 4000/- (Rs. Four Thousand Only) as a security deposit within 10 days from the date of order acceptance.
- MSSCL will not pay any interest on this deposit.
- The deposit should be made by Pay Order/DD or RTGS from any nationalized/scheduled bank, valid for the contract period. It will be refunded without interest after the contract period is completed ( After 6 Month) & there are no issues with performance.

#### 5. Agreement:

- The successful firm must execute an agreement with MSSCL on a Rs. 500/- non-judicial stamp paper within one week (7 Days) of the work order.

#### 6. Preference:

 Preference will be given to those with proven experience in manufacturing or dealing with furniture.

#### 7. Payment Terms:

- 90% of the payment will be released after the successful completion of work and delivery of furniture as per MSSCL specifications.
- 10% of the payment will be released after 6 months from the date of agreement or upon successful completion of work, whichever is earlier.
- All payments will be made through RTGS/NEFT via the PFMS portal.
   TDS will be deducted as per Income Tax rules.

#### 8. Rights Reserved:

 MSSCL Management reserves all rights, including changes to terms and conditions. MSSCL reserves the right to accept or reject any or all quotations, cancel the quotations, or split the order among multiple parties at the tender's lowest rates without providing reasons.

#### 9. Completion and Penalty:

The L1 party must complete the work within the stipulated period of 6 months. Failure to do so will result in a penalty as decided by MSSCL Management. An extension may be granted for delays beyond control with approval from the Hon. Managing Director, MSSCL, Akola.

#### 10. Arbitration:
