- One set of photo-copies of all the certificates and testimonials duly attested/self attested as referred above at 1 (iii).

3. You have to produce 'NOC' at the time of interview from your present employer, if employed in Govt., Semi Govt., PSU, autonomous/statutory bodies and societies (not in case of Private Company) failing which you will not be allowed to appear before the Selection Committee.
4. Outstation candidates attending interview shall be reimbursed 3<sup>rd</sup> AC single to & fro railway fare by shortest route on production of proof of journey or actual fare whichever is less subject to production of NOC as mentioned above (only for candidates called from outside Delhi & NCR)
