Steno Test Evaluation Process:

Some Definitions & Their Uses

HALF MISTAKES:

- Omission of a full stop and essential comma
- Addition of a stroke
- If proper noun and opening word of a sentence does not start with capital letter.

FULL MISTAKES:

- Wrong spelling of a word
- Omission of word/figure.
- Addition of a word/figure not in the Passage.
- Substitution by a wrong word/figure.

No mistake to be counted for joining a word without Hyphen, extra space, word written in figure and vice versa; comma, paragraph.

If same spelling mistake is committed, say, at five times, then it will be treated as one mistake.

Note: Concept of Half Mistake and Full Mistakes is used in Steno typing. This concept is used where paper printer matter is given for typing. Or On-screen matter with no highlight and no scroll features are provided. Back space and delete key are generally fully enabled till time over. Definite number of words is given. If user types the whole matter and time remains, user can edit the typed matter anywhere in the typing area from start to end.

Marks Calculation Formulae in Steno:

Marks = 100 - ((Errors * (100 - Admissible error))/ Admissible error)

For Ex:

If Errors are = 12.5, admissible errors are 5 % i.e. 50 on 1000 words

= 100 - ((12.5*50)/50)Then Mark

=87.25

However, Max Marks allowed to = 100

Steps and Process:

Instruction and Trial dictation: 2 Minutes (including 200 words)

Final Dictation: 10 Minutes.

Total Words dictated: 1000 words @ 100 Word per minute for 10 minutes duration.

Reading Time: 10 Minutes

Typing /Scripting Time: 50 Minutes

Typing of passage / Transcription shall be done on customized editor software having auto close system of 50 minutes. After its completion Printout shall be taken for each candidates output and to be signed by candidate and NSCL observer and will be send to evaluator.

Type Test Speed Calculation Formulas

Note: (1 word = 5 keystrokes, 1 error = 5 key strokes)

Formula:

Net Speed (WPM) = [(Gross Strokes-Error hits)/5]/Total Test Time (Min)

Example:

Duration: 10 min Gross Strokes= 1866

Error hits = 50 (10 errors*5)

Gross Speed = [(Gross Strokes)/5] / Total time i.e. 10 min

(Note: 1 word= 5 Key strokes)

Net Speed = [(Gross Strokes-Error hits)/5] / Total Time i.e. 10 min

=[(1866-50)/5]/10

=[(1816)/5]/10

=[363.2]/10

= 36.32 W.P.M

i.e. Net Speed = 36 W.P.M (round off incase decimal value is more than 0.5)

Note: delete, backspace, shift and other keys are not calculated in key stroke.

Calculation of Errors:

Errors are calculated by following two criteria

- 1. Errors that's corrected: If a candidate correct wrong word what they typed, then they can use backspace to delete that word and it will not calculated in WPM.
- 2. **Errors that's incorrect**: If a candidate will not correct the errors what they made, then they will penalized for 5 character for each word error (Regardless of how many characters

Formulae for Calculation of Marks:

Marks Obtained = $\{MM \times NS / QS\} - (QMP)$

MM = Maximum Marks Allotted for the speed test (say 100)

NS = Net Speed (obtained by the candidate) (say 42)

QS = Qualifying Speed (say 40)

QMP = Qualifying Marks Penalty i.e. [Max Marks – Qualifying Marks] = 100 - 40 = 60

Then Marks Obtained is = $\{100 \times 42 / 40\} - (60) = 45$

Note: Candidate has to login on a customized software of typing with his/her roll number and a password (provided at exam time only). Software has a facility to auto close after 10 minutes and will generate the typed output of candidate. After its completion Printout shall be taken for each candidates output and to be signed by candidate and NSCL observer.
