(iv) 05 latest passport size coloured photograph. (v) If applicable, candidates have to bring "No Objection Certificate" along-with Vigilance Clearance Certificate issued by the present employer (Govt. / Semi-Govt. / Autonomous body / society / PSU / PSB) in case candidates have not submitted application through proper channel.

After successful document verification and medical examination, candidates have to undergo **induction training** to be arranged by NSC in Head Office at above address from **13th June, 2019**. The lodging & boarding during the induction training period will be provided by NSC for the outside candidates other than Delhi & NCR from **12th June, 2019 (evening) to 14th June, 2019 (evening)**.

The expenses on the **medical examination (max. ₹ 1000/- approx)** will be paid by the candidate himself/herself and the actual expense will only be reimbursed to him/her after joining the post at the designated place of posting.

It is also informed that above candidates are required to report at schedule date, time and place for documents verification. **No extension or second chance will be provided.** Failure to report for the same, it will be presumed that he/she is forgoing the opportunity and his/her candidature will be treated as cancelled. **No further correspondence will be entertained in this regard.**
