## 1. <u>Recruitment of Project Director (PD) – One Post.</u>

- **1.1** The essential responsibilities for Project Director are as under:

  - PD shall be functioning under the direct supervision and control of INM Division of DAC&FW and shall be reporting to the Chairman Executive committee OVCDNER through Joint Secretary.
- 1.2 **Essential qualification and experience** A person with experience in the field of organic farming, preferably a postgraduate in any field of agriculture of related

discipline with minimum of 10 year of experience in project management scheme implementation and agriculture production and market / value chain development at senior position.
