CIRCULAR

Subject: Revised guidelines for Public Procurement Policy for Micro Small and Medium Enterprises

This is with reference to the revision in the Public Procurement Policy for Micro, Small and Medium Enterprises, 2012.

As per Public Procurement Policy for the Micro and Small Enterprises (MSE's order 2012) and subsequent guidelines issued on the subject including benefits to be extended to MSME bidders it is informed that the MSME vendors having Udyog Aadhar Memorandum or are registered with District Industries Centre (DIC) or Khadi and Village Industries Commission (KVIC) or Khadi Village and Industries Board (KVIB) or Coir Board or National Small Industries Commission (NSIC) or Directorate of Handicrafts and Handlooms or any other body specified by Ministry of MSME should be provided benefits under the said policy. Also as per Office Memorandum issued by dated 24.10.2016 issued by Ministry of MSME it is again reiterated that MSME bidders registered with above bodies or any other bodies specified by Ministry of MSME shall be eligible to avail the benefits under the policy.

Therefore, in view of the above all the Divisions/Regional Managers/Farm Heads are requested to adhere with the revised guidelines of the Public Procurement Policy, 2012 and provide the benefits under this policy to MSME bidders having valid registration certificate for the particular category of items for which the bidder has offered the bids.

The copy of Public Procurement Policy for MSME Order 2012, Press Release from office of Development Commissioner, MSME, dated 18.02.2016 and Salient features of Public Procurement Policy are enclosed with this circular for information and compliance.
