

**THE LOKPAL AND LOKAYUKTAS ACT, 2013-SUBMISSION OF DECLARATION OF
ASSETS AND LIABILITIES - REGARDING EXTENDING THE TIME LIMIT &
REVISED FORMATS**

Reference is invited to this office letters of even Reference Number dated 5.9.2014 & 8.10.2014 on the above subject wherein all the Group A, B & C Officers/officials of the HQ/Regional Offices/Farms were requested to file the revised Annual declarations Returns on or before the 31.12.2014.

Further, Director, Department of Public Enterprises, Government of India vide letter No. A-42011/10/2011-Admn.FTS-2332 dated 2.1.2015 has intimated that Government of India has extended the time limit for filing of return by all public servants from 31.12.2014 to 30.4.2015 vide its Gazette Notification dated 26.12.2014. In addition to above the Gazette Notification also prescribes a revised format for Form no. II & IV (copy enclosed) of Principal Rules under the Public Servants Rules, 2014 as notified under the Lokpal & Lokayuktas Act, 2013 on 14.7.2014.

In view of the above, All HODs/Regional Managers/Farm Directors are requested to bring the contents of the above notification to the notice of all employees to ensure compliance within the revised time limit. The complete format with revised Form No. II & IV is also placed on NSC website which may be used for filling of return.



**THE LOKPAL AND LOKAYUKTAS ACT, 2013-SUBMISSION OF DECLARATION OF
ASSETS AND LIABILITIES BY THE PUBLIC SERVANTS FOR THE YEAR ENDING
MAR 2014**

Director, Department of Public Enterprises, Ministry of Heavy Industries & Public Enterprises, Government of India vide letter No. A-42011/10/2011-Admin dated 5th August 2014 enclosing therewith a letter bearing No. 11013/3/2014-Estt (A) dated 23.7.2014 signed by Director (E), Ministry of Personnel, Public Grievances & Pensions, DOPT, Govt of India, wherein it has been informed that Government of India has notified the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the limits for exemption of Assets in filling Returns), Rules, 2014, under the Lokpal and Lokayuktas Act, 2013 on 14.7.2014.

As per Section 2 (1)(o) of the Act, "Public Servant" means a person referred to in clause (f) of sub-section (1) of section 14 of the Act, which clearly states that every public servant, who is or has been a chairperson or member or officer or employee in any body or Board or Corporation or authority or company or society or trust of autonomous body (by whatever name called) established by an Act of parliament or wholly or partly financed by the Central Government or controlled by it, shall file declarations, information or return as the case may be regarding his assets and liabilities as on the 31st March of every year to the Competent Authority on or before the 31st day of July of that year.

As per above Rules, the public servants (All Group A, B & C employees), who have filed declarations, information and Annual Returns of Property under the provisions of the Rules applicable to such public servants shall file the revised declarations, information or as the case may be, Annual Returns as on the 1st day of August, 2014, to the Competent Authority on or before, the 15th day of September 2014. From the year 2014-15, the information has to be submitted to Vigilance Division every year as on 31st March. In this regard, Appendix-I & Appendix II (Form I to IV) are attached for ready reference. NOTIFICATION

New Delhi, the 26th December, 2014

G.S.R. 981(E)- In exercise of the powers conferred by sub-section (1) read with clause (k) and clause (1) of sub- Section (2) of Section 59, Section 44 and Section 45 of the Lokpal and Lokayuktas Act, 2013 (1 of 2014) the Central Government hereby makes the following rules further to amend the Public Servant (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014 timely:-

1. (1) These rules may be called the Public Servants(Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Second Amendment Rules, 2014.

(2) They shall come into force on the date of their publication in Official Gazette.

2. In the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014 (hereinafter referred to as the principal rules), in rule 3, in the proviso to sub-rule (2), for the words "on or before the 31 day of December 2014", the words "on or before the 30th day of April 2015", shall be substituted.
